

It allows you to identify and examine the risks that you or your organization face, and helps you decide whether or not to move forward with a decision.


Allows an organisation with limited resource to deploy those resources in the most impactful way. 'You can't investigate everything, so who should you investigate?'





Delivering multi-dimensional visual analysis:




Temporal analysis to discover sequence of events alongside other known activities



Pattern analysis to identify key factors or similar streams of information

We are aware that there are sanctions associated with the organization.


We believe there are associations between the subject of concern and the organization.




How serious are the sanctions that have been put in place and what are the associated entities with those wider sanctions?


